Taxpayers are often unaware of important credits they are eligible for, leaving valuable dollars on the table. The Earned Income Tax Credit (EITC) helps you keep more of what you earned, from \$2 up to \$6,318. EITC changes based on:

- 1) If you are single or married
- 2) The number of children you have
- 3) The amount you earned. The Child and Dependent Care or Education Credit are among credits available to individuals and families filing a tax return. By working alongside a certified VITA IRS tax preparer, you can take advantage of valuable tax credits and receive full refunds that can help pay down debt or provide savings.
